## **Mitsubishi Electric to Repurchase Company Shares**

*According to Articles of Incorporation Pursuant to Article 459, Paragraph 1 of Companies Act of Japan*

**TOKYO, April 28, 2025** – [Mitsubishi Electric Corporation](https://www.mitsubishielectric.com) (TOKYO: 6503) announced today that the company's Board of Directors resolved on April 28, 2025 to repurchase shares of the company's stock, as shown below, pursuant to the provisions of Article 459, paragraph 1 of the Companies Act, as well as Article 31 of the company's articles of incorporations.

### **1. Reason for the Repurchase of Company Shares**

Based on the financial policies of Mitsubishi Electric, the company will repurchase its own stock to enhance shareholder returns and strengthen capital efficiency.

### **2. Details of the Repurchase**

- (1) Type of shares: Common stock
- (2) Number of shares: 60,000,000 shares (maximum unit)  
2.89% of issued and outstanding shares (excluding treasury stock)
- (3) Aggregate value: JPY 100 billion (maximum limit)
- (4) Period: April 30, 2025-October 31, 2025
- (5) Method: Market trades on Tokyo Stock Exchange

Note: Part or all of the above-mentioned repurchases might not be performed depending on market conditions and other factors.
